Last weeks motion was voted on at this time. The motion read; "Moved that the Chapter Room Fund be liquidated and all moneys returned to the brothers involved." The motion passed (8-2- )

Moved (Cleveland) that \$10.00 be appropriated for incidental running expenses of the Comm, with the hope of future reimbursement. The motion passed unanimously.

It was moved that An APO-Wso coordinating comm. not be appointed. (Mitchel-Haynes). The motion passed.

16. It was moved and seconded th t KO cast a favorable vote for the admission of Princeton Univ. Nebraska tate, and Davidson College into membership of APO. Mot on passed. Material enclosed.
